## Introduction

Newydd Housing Association was first established in 1974. In 1998, a group structure was formed with The Cadarn Housing Group as the parent company and Newydd Housing Association (1974) Ltd as a subsidiary. Three more companies have since been added to the group, Living Quarters (Lettings and Sales) Wales Ltd and Newydd Maintenance Ltd and in 2024 the group expanded to include Cadwyn Housing Association Ltd.

#### **Cadarn Group Limited**

Co-operative and Community Benefit Societies Act 2014. Non-charitable rules. Parent of Group; provides oversight and support services role.

## Newydd Housing Association (1974) Limited

Co-operative and Community Benefit Societies Act 2014. Charitable rules. Landlord – owns and manages 3,000 homes for affordable rent and low-cost home ownership as well as a range of community regeneration initiatives.

#### Cadwyn Housing Association Limited

Co-operative and Community Benefit Societies Act 2014. Charitable rules. Landlord – owns and manages 2,000 homes for affordable rent and low-cost home ownership as well as a range of community regeneration initiatives.

#### **Newydd Maintenance Limited**

Company Limited by Shares. Sole shareholder is Cadarn Group Ltd. In house contractor providing responsive and planned works to Newydd Housing Association.

## Living Quarters (Lettings & Sales) Wales Limited

Private Company Limited by Shares. Sole shareholder is Cadarn Group Ltd. Manages a small portfolio of market rent properties for Newydd Housing Association and private landlords.

#### Igneous

Private Company Limited by Shares. Sole shareholder is Cadwyn Housing Association Ltd. Design and Build subsidiary of Cadwyn with experience of open market sales. Owns 35 freehold units.

## Introduction

Cadarn Group Ltd has a shared vision across the Group members to provide affordable, safe and high-quality homes to all those who need them and support sustainable communities with excellent services to tenants.

In order to do that, the Board has developed this Corporate Plan to drive the organisation forward and ensure that we collaborate to deliver the policy aims of Welsh Government and our Local Authority partners.

Cadarn Group is committed to embracing sustainable practices and innovative technologies to transform our homes and buildings into beacons of environmental stewardship. This journey towards decarbonisation is not just about reducing emissions; it's about creating healthier, more resilient communities for future generations.

Welsh Government is committed to providing 20,000 new low carbon homes by the end of the current government term. Cadarn Group aim to contribute to this strategic aim by delivering 450 low carbon homes over the term of this corporate plan across our principal local authority areas.

Cadarn Group wants to play its part in addressing the climate emergency and aims to assist the Welsh Government through the Optimised Retrofit Programme to reduce carbon emissions across our stock.

Safety for tenants, the quality of housing stock and our value for money remain high priorities for the Board. Cadarn Group aims to ensure tenants live in safe, affordable, high-quality homes, receiving excellent landlord services.

Having a clear strategy demonstrates that we appreciate the scale of the challenges we face, from retrofitting over five thousand homes to become zero-carbon and meeting higher building safety standards, to exploring new ways of raising the significant funding needed to continue to build more of the right homes, in the right places.

Alongside our targets to improve Cadarn and guide investment decisions going forward, the group will maintain its focus and commitment on key areas of success already achieved. The Cadarn DNA will also influence everything we do on a daily basis and will ensure that all activity and decisions build upon the previous success and commitments.

- Invest in staff education and wellbeing to ensure that our tenants receive the highest levels of service.
- Remain open to opportunities that generate commercial profits through our subsidiary companies that can be reinvested in the group's core social purpose.

Harnessing this work to create the Group's visions, values and objectives provides the golden thread from the partnership business case to the delivery of the desired outcomes for Cadarn.

This corporate plan sets out that journey for the next 3 years but lays the foundations for a much longer journey for the next 30, maybe 50 years and ensures Cadarn Group are on track to continue to support our tenants and communities to grow in a sustainable, safe environment while ensuring high accountability and good governance.

- We recognise and praise good performance.


## What do we want to do?
